- Whether you have FTTB or FTTN

Installation and setup costs

In addition to the monthly charge, you may pay the following;

Self-activation <i>*charges will apply for onsite installation</i>	No charge
Onsite installation	\$190 (ex. GST) per hour if you request a technician at your premises
Connecting to the NBN network	NBN Co charges \$300 (ex. GST) for first-time connections in new developments. If this additional NBN Co charge applies, we will let you know and include it on your bill

Moving to the NBN network

Your 24-month contract could overlap with the rollout of the NBN network. If you wish to transfer to EHW on the NBN network, please contact us. If you don't, we will continue to provide your service up until the date on which we are required, by law, to disconnect your services. No Early Termination Charge (ETC) will be charged in these circumstances.

NBN Speed Change

Should you wish to downgrade or upgrade your internet speed, a fee of \$30 (ex. GST) per request is charge.

Early termination Charges (ETC)

If you cancel your service, you'll be charged an Early Termination Fee (Disconnect prior to 24 months contract) of \$300 (ex. GST)
